BARBARA CATT RN BScN MEd CIC has worked in the field of Infection Prevention and Control for many years. She has been involved in research and publications regarding disease transmission and education such as core competencies. She has been working at SHSC since 2003 as an IPAC Coordinator, PPL. She played a major role in curriculum development and implementation of core competency certification and hand hygiene initiatives. She continues to be an active member with IPAC Canada, APIC, CON, and RNAO.

Barbara is a past member of IPAC Canada Standards and Guidelines and HealthPro Clinical Advisory Committees and past president for IPAC Greater Toronto and Area. She continues to be an active participant on committees such as IPAC Canada Prehospital Care Interest Group, chair of IPAC Canada Education Core Committee and has served as a Board Member for IPAC Canada since 2013, holding the position of Director (Education).
