



2017 Champions of Infection Prevention and Control Award Information and Criteria for Selection

About the Champions of Infection Prevention and Control Award

In collaboration with 3M Canada, IPAC Canada established the Champions of Infection Prevention and Control Award in 2009. The Award recognizes IPAC Canada members who have demonstrated innovative initiatives to prevent infection, raise awareness, and improve the health of Canadians. The candidate may also be nominated for lifetime achievement. The nomination may be made by a member of IPAC Canada or by an IPAC Canada chapter. Formal presentation of the Award will be made at the Opening Ceremonies of the 2017 National Education Conference (Charlottetown, June 18, 2017).

Candidate Requirements

All candidates must meet the following requirements in order to be considered for this award.

- IPAC Canada member in good standing the year of the nomination and the award
- IPAC Canada Chapter member in good standing the year of the nomination and the award
- Current Certification in Infection Control (CIC®) is preferred but not mandatory.
- Must not be a current member of the IPAC Canada Board of Directors or a representative of Industry.
- Has not received the Champions award within the past five years.

Candidate(s) agree(s) that, if chosen for this award, they will present a 15-minute Oral Presentation (12 minute presentation; 3 minute Q&A) on the project/initiative that resulted in their award. This will be presented on Tuesday, June 20, 2017 at the Breakfast of Champions, 2017 National Education Conference, Charlottetown.

Criteria for Selection

The IPAC Canada Executive and a representative of 3M Canada will select the award winner(s) based on the following set of criteria. A grading system has been assigned to each criterion.

- A completed nomination form containing mandatory and qualifying information has been submitted. (8 points)
- The nomination essay provides adequately detailed information and completeness of content on which to base judgement. (10 points)
- The essay must

Explain the candidate's role in the project/initiative and a description of the project/initiative with specifics as to:

- Objectives
- Evaluation
- Methodology
- Sustainability

(10 points)

Show that the candidate has demonstrated meaningful evidence of a significant impact in one or more of the relevant areas (possible 12 points):

- Process and Systems Improvement
- Program Development
- Advocacy, Influence and Leadership
- Education
- Patient Safety
- Cost Effectiveness

Show that the candidate has demonstrated sustainability of the project/initiative or a plan to implement sustainability.(5 points) – OR

- The essay must show that the candidate has demonstrated lifetime/career-dedicated service to the reduction of healthcare acquired infections in any healthcare setting, giving specific examples of challenges, projects and sustained success. (possible 27 points)

- The judging panel may identify other areas in the essay for Additional Consideration (5 points)
- Program reach may include both setting-wide or targeted, and facility-based or community-wide impact.
- A maximum of 2 award winners may be chosen in any one year.
- **The IPAC Canada Board of Directors (the Board) and 3M Canada also has discretion to name an award winner in the event nominations do not result in a winner of the award.**
- IPAC Canada and 3M Canada reserve the right to decline to present the award in any year.
- Nominations not chosen for an award may be resubmitted the following year.

NOTE: The template for submission of the nomination essay must be used and is available at www.ipac-canada.org (Opportunities).

The Award Consists of:

- Travel to and from the 2017 National Education Conference (Economy Air Travel or ground travel to maximum of equivalent of air travel)
- 2 nights' accommodation at the official conference hotel (room and tax only)
- Waived registration for the 2017 National Education Conference (Monday-Wednesday only), not including special events.

Award winner(s) must book their travel and accommodation and request reimbursement through submission of Form 7 along with detailed receipts. GST or HST paid must be clearly identified on the receipt/invoice. Registration for Monday-Wednesday will be waived by IPAC Canada. If the applicable registration has already been paid, reimbursement may be requested by the award winner(s).
