



MEMORANDUM TO IPAC CANADA MEMBERS RE ELECTIONS TO BOARD OF DIRECTORS

CANDIDATE PROFILES



Colette Ouellet RN BN MHA CRM CIC began her career as a nursing officer in the Canadian Armed Forces, and was fortunate to have experienced postings in Winnipeg, Halifax, Ottawa and Germany during her military career.
