1. Background and Justification

* Purpose of the Position

In the context of the WHO Health Emergencies Incident Management System (IMS), at the country level, the incumbent will provide technical support and guidance to the Ministry of Health and partners on strategic, organizational and operational aspects of a comprehensive Infection Prevention and Control (IPC) programe/activities at the country level. S/he will manage IPC activities, provide technical guidance to ensure alignment with the WHO recommended standards for IPC, monitor and ensure accountability of the implementation of the WHO IPC programme activities throughout the full cycle of incident management.

Objectives of the Programme and of the immediate Strategic Objective

The mission of WHO's Health Emergencies Programme (The Programme) is to help countries, and to coordinator international action, to prevent, prepare for, detect, rapidly respond to, and recover from outbreaks and emergencies.

Organizational context (Describe the individual role of incumbent within the team, focusing on work environment within and outside the organization)

Supervised by the Team lead and under the overall guidance of the Incident Manager and Head of the WHO Country office, and working closely with counterparts at the respective regional office and HQ, the incumbent will act as the incident management's technical lead for IPC. S/he will manage the IPC component of the incident management system, assessment, support the revision and update of the IPC measures and practices, and provide technical guidance to the Ministry of Health (MOH) and partners. S/he will establish and maintain good collaboration with partners, and synergize with the WHO deployed IPC staff, liaise with other units/teams within the country office, across the organization and partners for facilitating the development of a detailed work plan and budget for WHO operations.

The incumbent will be responsible for coordinating the implementation of the approved activities and

to ensure alignment of purpose between headquarters and the regional office on matters related to IPC. S/he will also be responsible for reporting, performance assessment and evaluation of the planned activities, for monitoring the availability and flow of financial resources and ensure proper communication with partners and as appropriate.

- 1. Lead the development of infection prevention and control (IPC) core components for preparedness, response and recovery of outbreaks and health emergencies.
- 2. Provide technical guidance to national infection prevention and control IPC programme on preparedness and response to outbreaks and health emergencies.
- 3. Provide technical guidance to the national IPC programme on reducing healthcare associated infection, ensuring that IPC priorities and activities are managed effectively in compliance with WHO IPC guidelines.
- 4. Provide guidance and technical advice for the prevention of the spread of severe emerging infectious diseases through development, dissemination and evaluation of guidelines and implementation strategies.
- 5. Ensure restoration of safe basic health services and implementation of the minimum IPC measures.
- 6. Assess training needs, develop training materials and conduct and/or supervise IPC training for staff at district hospitals and health facilities according to the review of IPC measures.
- 7. Review the IPC measures implemented in the affected areas and advise on prevention of healthcare associated infections in healthcare settings. Co-develop and outline the implementation of a national IPC strategy in regards to measures pertaining to enhancement of Standard Precautions.
- 8. Report to MOH/WHO international incident management team on findings, and activities, and advise on effective and feasible IPC activities in areas affected by the incident.
- 9. Perform any other related incident-specific duties, as required by the functional supervisor.
