## COURSE STRUCTURE

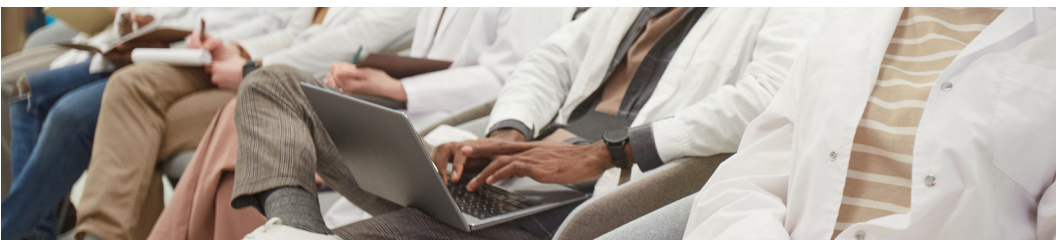
- 1. Online Preparation:**
